GENERAL MANAGER/CEO STEVE YOUNG

AT HAMILTON COUNTY ELECTRIC COOPERATIVE, we take seriously our duty to provide reliable

electricity to our members in the safest, most affordable manner possible. Though we work hard to fulfill that promise year-round, perhaps there is no better time to reiterate our commitment than during National Electrical Safety Month.

Over these next few weeks, as our lineworkers and behindthe-scenes staff go about their vital work as steadfastly as ever, we ask you, our members, to consider your role as our partners one-fiftieth the amount used by a 60-watt lightbulb. You should not swim near a dock or marina unless you know its wiring is in good repair. You should also never swim near a boat while it's running.

If you see an electric shock drowning taking place, never enter the water. You could become a victim, too. Turn the power off if possible, call 911 and throw a life preserver to the victim or reach out with a fiberglass hook to help the victim get out of the water.

We recommend hiring a licensed electrician to inspect home pools, spas and hot tubs and make any repairs or upgrades necessary to keep the wiring up to date and safe.

Here are a few additional tips for enjoying a day at the pool without risking your wellbeing or anyone else's:

- ▶ Outdoor electrical outlets (including pools and spas) should be covered and kept dry when not in use.
- ▶ Use a ground-fault circuit interrupter for electrical devices used outdoors. Portable GFCIs are available for \$12-\$30 and don't require tools for installation.
- ▶ Make sure all electrical equipment used for swimming pools, including cleaning equipment, is grounded and working properly. If you notice pool lights flickering, stay out of the water until a licensed electrician has resolved the issue.
- ▶ Electrical devices and cords should be kept at least 10 feet away from pools and spas. Whenever possible, use battery-powered devices outdoors instead.
- ▶ Never handle electrical devices while you are wet, either from swimming or perspiration.
- ▶ Make sure there are no power lines over a swimming pool, and never swim during a thunderstorm. Thunder means lightning is close enough to put you at risk of electrocution.

Our intent in relaying this information is not to frighten but to illustrate how we all must keep a watchful eye toward safety whenever and wherever electricity is present, and remain especially vigilant in settings where its presence may not be obvious.



in ensuring your comfort and safety. Amid the drumbeat of daily routines, balancing work and family, we all can sometimes grow complacent about seemingly innocuous habits or practices that could bear tragic consequences.

One critically important example of this during swimming and boating season involves the risk of electric shock drowning. Docks and marinas carry electricity sources, which faulty wiring or damaged cords can release into water invisibly. As few as 10 milliamps can cause paralysis and drowning. That is

dishwasher or refrigerator? If you time it right, you can enjoy a tax-free purchase on qualifying appliances soon. The statewide Energy Star Sales Tax Holiday takes place Memorial Day weekend. This year, it begins Saturday, May 26, at 12:01 a.m. and concludes Monday, May 28, at 11:59 p.m.



Eligible tax-free appliances include:

- ▶ Air conditioners (models priced at \$6,000 or less)
- ▶ Refrigerators (models priced at \$2,000 or less)
- ▶ Ceiling fans
- ► Clothes washers

- ▶ Incandescent and fluorescent lightbulbs
- ► Dishwashers
- ▶ Dehumidifiers
- ▶ Programmable thermostats

Keep in mind that appliances purchased for just a few dollars over the allowable amounts will be fully taxed. For example, a refrigerator that costs \$2,050 will be taxed on the entire purchase price, not just the \$50 in excess of the limit. Similarly, if an item's sale price is within the price cap but an additional delivery fee pushes it over the limit, the entire purchase is taxable.

Start researching now so you can take advantage of savings on items that will likely lower your energy bills.

Notice of Director Election

THE MEMBERS OF HAMILTON COUNTY ELECTRIC COOPERATIVE WILL ELECT DIRECTORS BY MAIL-IN BALLOT FRIDAY, AUGUST 3.

In accordance with cooperative bylaws, a nominating committee was appointed by the board of directors at its regular board meeting April 26. The Nominating Committee will meet June 7 at 2 p.m. at the cooperative's main office at 420 N. Rice St. in Hamilton, to make nominations for directors to serve in districts 2 and 5. Terms of the incumbents in these districts expire this year.

 $\begin{tabular}{ll} \textbf{District 2:} The area east of U.S. Highway 281 in Hamilton \\ County. \end{tabular}$

District 5: The area west of U.S. Highway 281 in Lampasas County and including all areas in San Saba and Llano counties.

Members residing in District 2 or District 5 who wish to be considered as a candidate can contact the cooperative's main office at 1-800-595-3401 by May 31. Prospective candidates must meet the director qualifications as specified in HCEC bylaws (Article III Directors, Section 4.02 (a) Director Qualifications).

Ballots will be mailed to members July 11 and should be returned to the cooperative no later than 1 p.m., Friday, August 3, at which time the ballots will be counted. The results of the election will be announced during Hamilton County EC's annual membership meeting Friday, August 3.

Following are excerpts from the bylaws of Hamilton County Electric Cooperative Association, which explain the nomination and election procedures.

ARTICLE IV DIRECTORS

SECTION 4.01. NUMBER AND GENERAL POWERS. The business and affairs of the Cooperative shall be managed by a Board of seven (7) Directors or under their authority, and subject to the Board's direction and oversight. The Board shall exercise all of the powers of the Cooperative except such as are by law or by the Cooperative's Articles of Incorporation or Bylaws conferred upon or reserved to the Members and such as the Board may delegate to or authorize to be performed by the Cooperative's management and employees.

SECTION 4.02. QUALIFICATIONS. A Director or Director candidate must comply with the following Bylaw provisions:

- **(A) DIRECTOR QUALIFICATIONS.** To be eligible to become or remain a Director of the Cooperative, a person shall:
 - (i) Be a natural person;
- (ii) Be a Member of the Cooperative for a period of twenty-four (24) consecutive months immediately prior to election;
- (iii) Be a Member in good standing with the Cooperative and shall not have (or if a Joint Member with a spouse who has) one or more accounts with the Cooperative or its affiliates that are not in good financial standing, or have (or if a Joint Member with a spouse who has) a controlling interest in another entity, association, organization, or trust that has one or more accounts with the Cooperative or its affiliates that are not in good financial standing;

- (iv) As provided in Section 1.04(f) of these Bylaws, in a Joint Membership, either spouse may serve as a Director, but not simultaneously, and only if both spouses meet the qualifications for Director as stated herein; otherwise, neither spouse may serve as Director;
- (v) For at least twenty-four (24) consecutive months immediately prior to election and throughout such person's term as Director if elected, maintain a principal place of residence, as required to claim such person's residence homestead exemption pursuant to Chapter 11 of the Texas Tax Code, in the District for which such person seeks election or was elected:
- (vi) Receive electric service from the Cooperative at such principal place of residence;
- (vii) Not be employed by the Cooperative or have been an employee of the Cooperative within twenty (20) years of serving on the Cooperative's Board of Directors;
- (viii) Not be a close relative of an incumbent Director or of an employee of the Cooperative, unless otherwise determined by the Board of Directors in its sole discretion;
- (ix) Not hold office as a Director who is an incumbent or candidate for public office for which a salary or wage is paid;
- (x) Not be in any way employed by or financially associated in a competing enterprise, or a business selling electric energy or selling products or services to the Cooperative;
- (xi) Unless excused by the Board of Directors, which action shall be noted in the minutes of that meeting of the Board of Directors, not miss three (3) consecutive regular meetings of the Board of Directors, or miss three (3) regular meetings of the Board of Directors within the most recent twelve (12) month period; and
- (xii) Not have been convicted of a felony in this State or any other State.
- **(B) DIRECTOR DISQUALIFICATIONS.** After being elected or appointed, if a Director does not comply with all Director Qualifications, the Board shall disqualify the Director and the individual is no longer a Director if:
- (i) The Board notifies the Director in writing of the basis for the disqualification, and provides the Director an opportunity to comment regarding the Board's proposed disqualification; and
- (ii) Within twenty (20) days after the Board notifies the Director of the proposed disqualification, the Director neither complies with nor meets the Director Qualifications.

SECTION 4.03. ELECTION. Election of Directors shall be held annually by mail-in ballot in accordance with Section 3.07 of these Bylaws.

SECTION 4.04. TENURE. Directors shall serve a term of three (3) years or until Director(s)' successor(s) has been elected or appointed. Upon the Directors' election, Directors shall, subject to the provisions of these Bylaws with respect to the removal of Directors, serve until the annual meeting of the Members of the year in which such Directors' terms expire or until such Directors' successors shall have been elected and shall have qualified. Whether elected or

appointed, Directors shall have qualified subject to the provisions of these Bylaws with respect to removal or resignation of Directors. Failure of an election for a given year shall allow the incumbents whose directorships would have been voted on to hold over only until the next Member meeting at which a guorum is present.

SECTION 4.05. DIRECTORATE DISTRICTS.

- (a) The territory served by the Cooperative shall be divided into the following seven (7) Directorate Districts with each District represented by one Director, who has his or her principal place of residence in that District, as provided in Section 3.02 (a)(v) of this Article:
- (1) The area West of U.S. Highway 281 in Hamilton County, designated as "District 1";
- (2) The area East of U.S. Highway 281 in Hamilton County, designated as "District 2":
 - (3) The area in Coryell County, designated as "District 3";
- (4) The area East of U.S. Highway 281 in Lampasas County, designated as "District 4";
- (5) The area West of U.S. Highway 281 in Lampasas County, including all the area in San Saba and Llano Counties, designated as "District 5";
- (6) The area South of U.S. Highway 84 in Mills County and West to the Cooperative boundary line, designated as "District 6"; and
- (7) The area North of U.S. Highway 84 bounded on East by Hamilton County line and on West by Cooperative boundary line, designated as "District 7."
- (b) The Board of Directors shall annually review and if necessary, re-divide and/or geographically relocate Districts to ensure that Director Districts equitably represent the Members.
- (c) Within sixty (60) days following any Director District revision, and at least sixty (60) days before the next Annual Member Meeting, the Cooperative shall notify any Members affected by the Director District revision by mail using direct mail, billing inserts, or the Cooperative's monthly magazine.
- (d) No Director District revision may: (1) increase an existing Director's term, or (2) shorten any existing Director's term unless the affected Director gives written consent.

SECTION 4.06. NOMINATIONS.

(A) NOMINATION BY COMMITTEE.

- (1) COMMITTEE QUALIFICATIONS. It shall be the duty of the Board of Directors to appoint, not less than thirty (30) days prior to the date on which Directors are to be elected, a Committee on Nominations, consisting of:
- (i) Not less than five (5) and no more than eleven (11) members of the Cooperative:
- (ii) Members who are not existing Cooperative employees, agents, officers, Directors or known candidates for Director;
- (iii) Members who are not close relatives (as hereinafter defined) or members of the same household of such existing employees, agents, officers, Directors or known candidates for Director; and

(iv) Members who are selected from different geographical sections so as to ensure equitable representation, including at least one (1) Member from the Directorate Districts to be filled at the election.

(2) COMMITTEE NOMINATION PROCESS.

- (i) The Committee shall prepare and post at the principal office of the Cooperative at least twenty (20) days prior to the date of the election of Directors a list of nominations for Directors to be elected. listing separately the nominee(s) for each Directorate District from or with respect to which a Director must, pursuant to this Section, be elected.
- (ii) The Committee may include as many nominees for any Director to be elected from or with respect to any Directorate District as it deems desirable.
- **(B) NOMINATION BY PETITION.** Any one hundred fifty (150) or more Members of the Cooperative, acting together, may make additional nominations in writing over such Members' signatures, listing the Members' nominee(s) in like manner, not less than forty-five (45) days prior to the date the votes are to be counted, and the Secretary shall post such nominations at the same place where the list of nominations made by the Committee is posted.
- (C) NOTICE OF NOMINATIONS. The Secretary shall mail to the members with the notice of the meeting of the Members at which Directors are to be elected, or separately, but at least ten (10) days prior to the date of such meeting, a statement of the names of all nominee(s) for each Directorate District from or with respect to which one or more Directors must be elected, showing clearly those nominated by the Committee and those nominated by petition, if any. Notice of nominations shall be in accordance Section 3.06 of these Bylaws, subsection (a)(2)(i) for nominations by Committee on Nominations and subsection (b) for nominations by petition.

Notwithstanding the provisions contained in this Section, failure to comply with any of such provisions shall not affect in any manner whatsoever the validity of any action taken by the Board of Directors after the election of Directors.

SECTION 4.07. VOTING FOR DIRECTORS: VALIDITY OF BOARD

ACTION. The election of Directors shall be held annually by mail-in ballot. Each Member shall be entitled to cast only one vote for each Directorate District for which a Director is to be elected. Ballots marked in violation of the foregoing restriction with respect to one or more Directorate District shall be invalid and shall not be counted with respect to such District or Districts. Notwithstanding the provisions contained in this Section, failure to comply with any of such provisions shall not affect in any manner whatsoever the validity of any action taken by the Board of Directors after the election of Directors.

SECTION 4.13. "CLOSE RELATIVE" DEFINED. As used in these Bylaws, "close relative" means a person who, by blood or marriage, including half, foster, step and adoptive kin, is either a spouse, child, grandchild, parent, grandparent, brother or sister of the principal.

Practical Pointers for Electrical Safety Month

MAY IS NATIONAL ELECTRICAL SAFETY MONTH, AND HAMILTON COUNTY ELECTRIC COOPerative is working to raise awareness about potential home electrical hazards and the importance of electrical safety.

Our modern lives depend on electricity, and if you don't properly maintain your electrical products, they can create hazards. The good news is that eliminating electrical hazards from your home doesn't have to be difficult or expensive.

Many homes and their electrical systems were built before most modern-day home electronics and appliances were even invented. Today's increased demand for energy can overburden an older home's electrical system. If you notice flickering or dimming lights, it may indicate your home's wiring is inadequate for your needs. Have it checked by an electrician.

Hamilton County EC offers the following tips to help identify and eliminate electrical hazards to protect yourself, your family and your home:

- Make sure televisions, game systems and computer equipment have plenty of space around them for ventilation.
- Use extension cords as temporary solutions only.
- Do not place extension cords in high-traffic areas or under carpets.
- Use a surge protector to help protect your computer, televisions and other electronic equipment from damage caused by voltage changes.
- Heavy reliance on power strips is an indication that you have too few outlets for your needs. Have additional outlets installed by a licensed electrician.
- Keep liquids away from electrical items such as televisions and computers.
- ▶ Make sure a lightbulb's wattage is right for the fixture. Lightbulbs with wattages that are too high for the fixture can overheat and cause a fire.
- Create a guide for your breaker box so that you know which breaker to turn off when needed.
- Recurring tripped circuit breakers or multiple blown fuses can signify a serious and dangerous electrical problem. Contact a licensed electrician immediately. As always, Hamilton County EC encourages you and your family to stay safe.
